Pursuant to Art. 38 of Presidential Decree. no. 445/2000, the form must be signed by the applicant aged 18 or over in the presence of the employee in charge, or signed and submitted, together with a non-certified copy of an identity document and the tax code of the signatory, also through a third party.

The veracity of the declarations made is subject to verification.

General information on sport fishing in Friuli Venezia Giulia

The fisher must carry and show at any request of the supervising personnel:

1. valid identity document;
2. FVG sport fishing licence issued by the ETPI, or alternatively, if the latter has not yet been issued by the ETPI licencing offices, the Extra Regional licence;
3. receipt of payment of the yearly or intra-year fee for sport fishing in FVG;
4. duly completed yearly (DRA) or intra-year (DRI) registrations document.

FVG fee: It is possible to pay the fee via APPesca.FVG or with the payment form pre-printed by the Licencing Offices or Issuing Points.

Trips and fishing activity: According to the current sport fishing calendar and its rules, available on the ETPI website (www.etpi.fvg.it).

- **Purpose of processing:** The data provided to ETPI to obtain documents for sport fishing registrations are processed in accordance with the provisions in force for the purposes of the procedure for which they were requested and are used exclusively for that purpose and for the institutional purposes of the Ente Tutela Patrimonio Ittico. Please note that ETPI, as a Public Administration, does not have to ask for consent to the processing and the processing is lawful if it is necessary to comply with a legal obligation to which the Controller is subject or when it is necessary for the performance of a task carried out in the public interest or in connection with the exercise of public powers vested in the Controller.

- **Retention period** of personal data: The data provided is stored by ETPI for an unlimited period, for statistical purposes.

- The **data subject has the right** to ask the Data Controller for access to his/her personal data and to rectify or erase it or to restrict or oppose its processing, as well as the right to lodge a complaint with the Data Protection Authority.

- The **data subject is obliged to** provide data for the purpose of accepting the application.
